Wonder Lake is a town located in McHenry Township. Founded in 1974 the town had a population of just over 1400 people in 2010 and now the estimated population is over 4000 year around residents which is a growth of over 200%. Wonder Lake is 61 miles northwest of downtown Chicago and the closest train into the city is located 8 miles away in Woodstock, Illinois.


Wonder Lake is 832 acre lake making it the largest private lake in Illinois. It is approximately 3 miles long with 7 miles of shoreline. Average depth is 6 1/2 feet with the deepest part of the lake, 14 feet, near the dam. There are 6 islands and 14 boat ramps. Each subdivision has their own beach, and those beaches are for use of residents with lake rights that do not have lake shore property. There are a total of 20 subdivisions and approximately 4000 deeded parcels that have lake rights.




### Aerial Map


